

What are Play Streets?

Play streets sessions are short, resident-led road restrictions to help neighbours to play safely and freely outside their own front door. Lower Hutt residents living on streets without much traffic who want to take advantage of the play areas right outside their doors for street parties and play can do so by completing the application. Local children who take part will need to be supervised by their caregivers. It's not just for kids, but a chance for neighbours of all ages to meet and build a neighbourhood. Making play easier and closer to home is a great way to increase activity levels and bring people together.

How does it happen?

- Contact the Active in the Hutt Team, active@huttcity.govt.nz
- Confirm your street meets the guidelines listed in the Low Risk Checklist (Pg 3 and 4)
- Consult with neighbours, 75% of residents affected must support the road restriction
 - Evidence needed, this can be documented on paper, through a social media platform or other source.
- Apply for road restriction
 - Community Road Closure Request Form included
- Plan with your neighbours
- Review health and safety documents with
 - volunteers at the closure(s)
- o Arrange for play gear
- Have a great time!





Completed applications should be handed in at least one month prior to the event date.

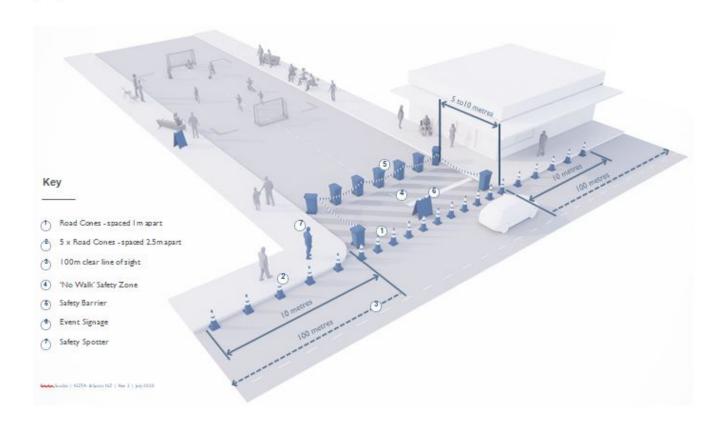

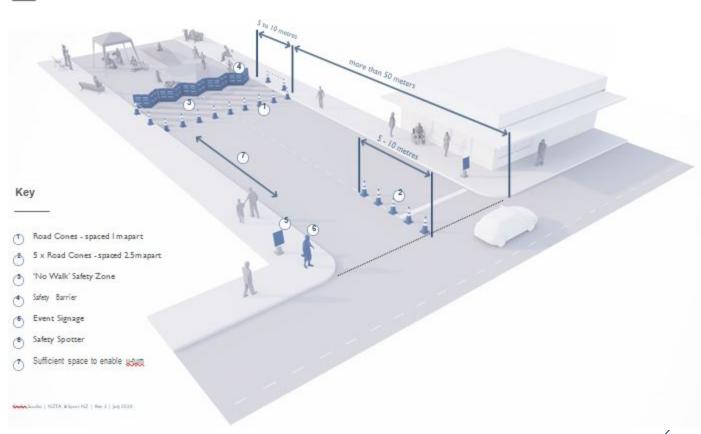




Option A_ Road closure at intersection- Busier road or intersection



Option B_ Road closure set back from intersection- Busier road



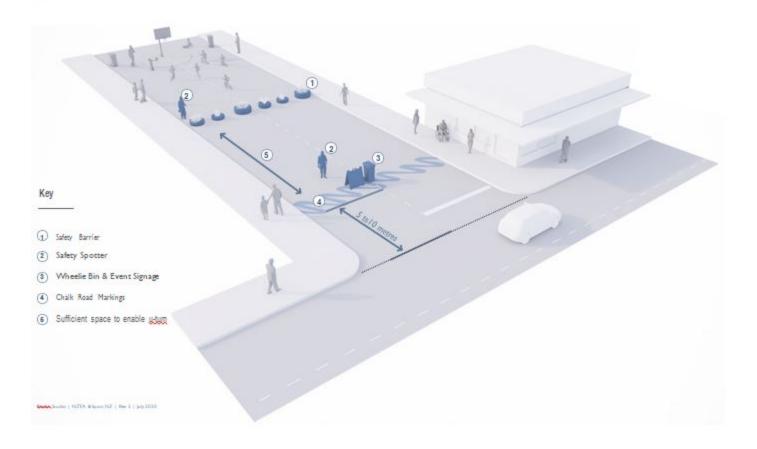

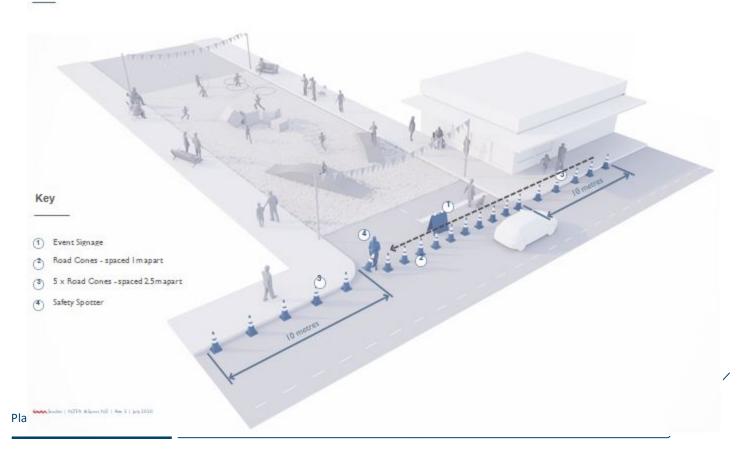




Option C_ Road closure set back from intersection- Quieter road

PART E: GENERAL TERMS, CONDITIONS AND GUIDANCE

- The organiser of the event is responsible for ensuring that all other normal regulations and by laws and legal compliance still need to be complied with such as council bylaws for noise, alcohol and dogs.
- Closing off part of a street as per this application provides a traffic exclusion zone for community events in line with the principles of CoPTTM. This is to be considered a 'road closure' for the purposes of the event but has no legal status and it is the responsibility of the organising party to ensure all affected persons and properties are effectively consulted with prior to the intended event date.
- The organiser of the event is responsible for ensuring that space must be available within the closure area for emergency access and egress, this area can be occupied as part of the event/activity but must be able to be cleared immediately if
- The organiser agrees that NZ Police and/or the council representative have the authority to cancel close down or stop the community closure and activities within the closure at any time.
- High visibility garments and suitable enclosed footwear must be worn when operating as a community traffic marshal within the road corridor.
- All unloading of equipment must be done from a legally parked position.
- Personnel undertaking this activity are required to move to avoid any moving vehicle and must not expect drivers to give way.
- Once in place, a responsible marshal must be within sight and easy access of the closure point(s) at all times.
- Marshals are expected to be vigilant and actively monitor vehicle activity and resident access requirements throughout the duration of the activity.
- These requirements do not replace the applicant's own health and safety policies or plans and a risk and safety plan should be developed for the event and held on site.
- If at any time it is considered that safety of those on the road has been compromised, the event activities must cease and remove all equipment from the road corridor before reopening the road
- All personnel undertaking the abovementioned activity shall be familiar with, and understand, the intentions and requirements of this plan.
- Any persons involved in this activity are reminded that it is their duty to postpone, cancel or modify operations due to adverse traffic conditions, weather or any other conditions that may affect the safety of this operation.
